The [2021 Law Firms Activity Report](#) presents data collected using machine learning and technology-assisted attorney review. Raw data is extracted from various sources, including PACER, and is cleaned, tagged, structured and loaded into Lex Machina's proprietary platform.

For the purposes of the report, Lex Machina defines a contracts case as a matter in which either at least one party is asserting a breach of contract claim, or both parties are business entities and at least one claim is based on a business tort such as fraud, conversion, or tortious interference with contract. Lex Machina defines business entities as corporations, partnerships, LLPs, and other legal entities that operate under a trade or business name other than that of an individual. While this report and ranking spotlights Lathrop GPM's Litigation capabilities overall, the firm's Franchise Litigation & Dispute Resolution team represented franchisor-clients in the majority of the cases associated with this report.
