Michael Cohen is one of the leaders of the Lathrop GPM Global Privacy, Cybersecurity & Data Protection Group.

The FIP designation signifies that he has demonstrated a heightened knowledge of privacy laws, privacy program management, and data protection practices with significant practical experience in these areas.
