## **Franchise Litigation**

- Obtained verdict and judgment in favor of national temporary staffing franchisor following a five-day bench trial against franchisee in federal court. The judge enforced a non-compete and non-solicitation provision against the franchisee defendant and conspiring co-defendants, awarded damages, attorney's fees, and costs in favor of the franchisor, and dismissed the franchisee's counterclaims.
- Prosecuted claims on behalf of national quick service restaurant franchisor against 15-unit franchisee who was committing pervasive employment eligibility verification violations. The case settled on terms favorable to the client.
