It is a converted railroad bridge that incorporates 65% dedicated public open space, restaurants, bars and coffee shops and other services intended to revitalize and repurpose unused and dilapidated infrastructure.

In addition to real estate law, Paul also focuses on public law, economic development incentives, land use planning and development, specifically including Chapter 100 Financing, the Missouri Works program, Chapter 353 Corporations, and Enhanced Enterprise Zones.

Prior to joining the firm, Paul was associate counsel at Americo Financial Life and Annuity Insurance Company, where he reviewed

estates, trusts, and powers-of-attorney in connection with the purchase of life insurance policies and conducted research for legal issues and regulatory compliance.
