These awards are granted in the belief that professionalism serves the best interests of clients, fosters respect and trust between lawyers and the public, promotes the efficient resolution of disputes, and improves the administration of justice.

Gene Hennig is the recipient of the 2010 Professionalism Award for a lawyer. The annual award is presented to a member of the Hennepin County Bar who "best exemplifies the pursuit of the practice of law as a profession, including the spirit of public service and promotion of the highest level of competence, integrity, and ethical conduct." was appointed one of Minnesota's commissioners to the National Conference of Uniform State Laws, an organization dedicated to improving the American legal system through the adoption of uniform state legislation.
