As security breaches involving credit card numbers, banking details, and employee HR records have proliferated, the state and federal governments have stepped up the regulatory regimes that govern the storage and transmission of personal data. This teleconference will address the risks of data breaches and the legal obligations that apply before and after a breach, and how they impact private enterprise, from small businesses to multinational corporations. The renowned speakers will cover what the FTC focuses on when it comes to personal data that employers hold, key action points contained in state regulations, including the California and new Massachusetts data privacy laws, which require pro-active steps by almost any company or law firm dealing with data, and best practices for legal practitioners when disaster strikes and personal data held by a company has been breached.
