Joining Lathrop Gage will be SSAB named partners John Shaeffer, David Aronoff and Lincoln Bandlow, along with four associates and nine staffers. Shaeffer will serve as partner in charge of the office, which will remain at SSAB's current location in Century City.

"Opening a Los Angeles office gives us a true national reach, but the real impetus for the move is the opportunity to work even more closely with an incredibly talented group of people," said Joel Voran, Lathrop Gage CEO. The SSAB intellectual property practice, which centers on the entertainment, advertising, computer game and media industries, is a natural fit for Lathrop Gage's IP capabilities, Voran said. Indeed, this combination creates a nationwide IP practice approximately 60 attorneys strong:
