## Experience

- Successfully defended a trustee at trial who was sued for breach of fiduciary and prevailed on counterclaim for reformation based upon mistake. The case was upheld by the Missouri Court of Appeals.
- Represented a trust beneficiary in two separate cases involving breach of fiduciary duty and trust interpretation, each time prevailing at trial and in the Illinois Court of Appeals.
- Represented a defendant sued in Illinois and Tennessee for breach of contract related to an antenuptial agreement and prevailed in both trial courts, successfully resolved case post-appeal.
- Twice prevailed at trial on behalf of plaintiffs in trust contests involving lack of capacity, undue influence, and family farms.
