Jury denies \$7M counterclaim in lab's lease dispute

A pharmaceutical company will get to keep its equipment in Kansas City following a federal jury's verdict in its favor.

Nostrum
Laboratories, based in
Somerset, New Jersey,
has a manufacturing
operation in Kansas
City for specialty
pharmaceuticals. The
plant's equipment was
acquired through seven capital leases from
Irvine, Californiabased Balboa Capital

Corporation.

that, upon expiration of the lease, it would obtain ownership of the equipment for a nominal fee. Balboa, however, maintained that the pharmaceutical company had to continue to make rental payments.

In a declaratory judgement suit filed in 2016 in U.S. District Court for the Western District of Missouri, Nostrum sought to enforce its understanding of the agreement. Balboa filed a counterclaim, alleging it was owed \$7 million plus return of the equipment.

After deliberating for 48 minutes on Aug. 8, the federal jury sided with Nostrum and denied Balboa's counterclaim. Michael Abrams of Lathrop Gage in Kansas City, an attorney for the pharmaceutical company, said his client didn't seek an award of damages. The contract entitles the winning party to attorneys' fees and costs, however, which Abrams said will be awarded at a later date.

Jason Dunn of Phillips Murrah in Oklahoma City, an attorney for Balboa, didn't return a call seeking comment.
